What are the components of a Bank?

1. An accounting system designed for customers
 1. "Customers are bank depositors, who entrust their money. . . for storage . . ." (Pîrvu, 2004, p. 31).
2. A physical and secure location to store money
3. Current practices of Federal Reserve Banks include providing loans, paying interest on deposits and a non-biblical outlook on usury
 1. In a later class, I will discuss a different form of banking. One I would prefer for the Republik and it *is* biblical.

What are the components of a Bank? (cont.) "accounting system"

- Transitional bank that can provide accounts for the Republik
 - <https://communities.cyclos.org/REPLIK>
 - One feature is it is free with no expenses which is perfect for a transitional bank.
 - The bank has all the accounting features of a "real bank" accept there is no requirement for Social Security numbers and it was created for Alternative Currencies such as the REPLIK. (BUT no storage)
 - The bank has a market side where goods and services can be advertised.
- The first bank can be transitional until full funding of the Republik becomes a reality. Please research this bank (see the demo account below) in order to make an informed decision to "vote it (and me) into existence". . .

What are the components of a Bank? (cont.)

How to actually spend REPLIK's

- Current spending of REPLIK's in public would be by using cell phones – similar to “Google Pay” or “Bitcoins”

- The Banking website allows sending and receiving money when dealing with customer to customer. Should a product or service be purchased that can be accomplished on the website also for any Republik account holder.
- A “Time Banking” feature can be part of the bank also.
- So this leads to the second part of a bank which is storage or vaults which protect against theft.

Who would buy Nickels

- FROM THE LINK I QUOTE: "From a value investment perspective, this is one of the safest plays out there. That's why billionaire *KYLE BASS* did exactly that several years ago – he bought \$1 million worth of nickels."
- One can go to a bank that has a coin machine and purchase a 50 pound bag of nickels that contains \$200 in nickels.
- I have purchased several of these and can give examples of how to keep them safe from thieves.
- One example is I keep one bag in my safe; it makes it so heavy that a lazy thief would never try to carry it away.
- But "WHY" nickels?

Why Nickels

- One could argue that when the Constitution designated Gold and Silver for coins, Nickel had NO value – but it does today.
- During World War 2, nickel was such a needed metal that they made nickels out of silver for 5 years.
- In a future class – *and this will be one of the best classes* - I will explain how members of the Republik can obtain more FRN's and these should be converted into nickels and allocated for the "transitional funding of the Republik"! (Gold and Silver coins could be used too)

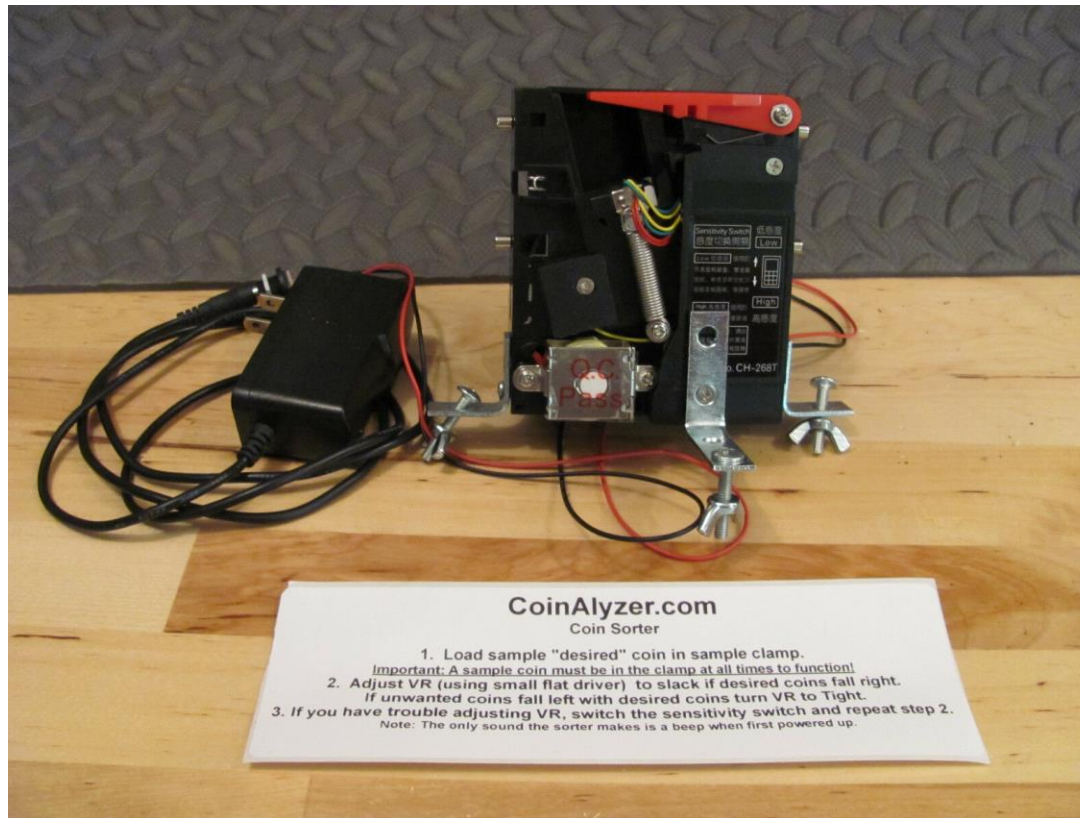
Why Nickels (cont.)

- There is NO downside risk.
 - If the economy/mineral prices goes up, the nickel in the coin goes up in value.
 - If the dollar collapses, the nickel coin is still work a nickel (to buy food or other items)
 - With this in mind; it makes a perfect “Community Builder”. When approaching local store owners, the Republik can explain they will never lose by accepting our alternative currency.
 - My intent is the REPLIK (REP) should be backed by value. (In the last class, I will divulge the best value backing for our money which will pay the Senators for their service).

Why Nickels (cont.)

- There is ONE downside risk.
 - Nickels can only feasibly be stored at home.
 - However, during this “Transitional Phase”, the loss of a bag of nickels would not be TOO damaging.
 - My suggestion is that a bank customer be “Placed on their Honor” and send a picture of their bag of nickels to prove the funding of their account. This leads to honesty and integrity. We need to begin to revive people standing behind their word.
 - Also, it would be paramount that when someone spends “a REPLIK” from their account, they make it clear it is backed by coinage. Should that entity ever want FRN’s, they would be refunded!
 - This makes using the REPLIK more sound than using FRN’s (which are only backed by debt).
 - Perhaps a great idea? But how can it be used?

First let me interject: But, what about "Copper Pennies"?



Pre-1982 “Copper Pennies”?

- The picture in the previous slide is a “penny sorter”
- A major downside is the separating of old and new coins
- This negative side of collecting/sorting Pre-82 pennies can be overcome by paying anyone interested with “Time Dollars” (a form of currency based on hours worked that will be discussed later).
- One question that might arise would be “why would someone want to give away their time sorting coins”?
- In the last class, I will divulge how one can *obtain a home* by using the ideas I am presenting.

BACK to NICKELS (and pennies)

- Beginning with nickels – and copper pennies – these can fund an immediate “Community Builder” idea(s).
- Coin Shortages: (when I first began forming my thoughts the coin shortage was everywhere)
 - From WashingtonTimes.com: “. . . the coin shortage of 2020 is certain to bleed into 2021.”
 - If there are “coin shortage” signs still in your area this is a perfect place to “fill a need”.
- Begin small purchases from local merchants and farmers markets.
- Consider the “market side” of the bank like a “Craigslist” and begin educating your County on the value of Alternative Currency. (The dollar will crash, it is just a matter of when)
- I will introduce an idea that will help with the work needed to build our communities. I am speaking to myself, if we don’t begin to build our community, the Republik will not grow anyway . . .

SheriffQ

- I believe one of the first things a County needs is “a new sheriff in town”.
- With this in mind; I have begun a website “SheriffQ.com” (if you go there, it is basic)
- My idea is to create yard signs to put up and move around the County.
- These are the least expensive form of advertising. And we don’t want to draw the wrong class of people either.
- Many have followed Qanon. The word SheriffQ will cause someone familiar with “Q” to check out the website when they get home. If a great site is built, it can tell the message that is needed.
- The first message will be an appeal for someone to fill such a position. I believe the Sheriff is a powerful office and such a website can describe the details needed for such a person. For instance; when the next vote comes around a page can be built for voting. The yard sign can read SheriffQ.com/NeedsYourVote.
- A commitment has been made by Sheriff Mack to teach any candidates to be “Constitutional Sheriffs”. Sheriff Mack does not think we should pay taxes and a Sheriff can help with that.

SheriffQ (cont.)

- The need for a Constitutional Sheriff is imperative.
 - As our current liberal led Government continues grow, we can see that they intend to take our freedoms away from us. A Sheriff can thwart those plans on a local level. FOX had Constitutional Sheriffs on the news that stated they will not require anyone to wear a mask in their County or require that businesses be closed. These are great examples.
 - As mentioned, one can legally/lawfully not pay taxes anymore.
 - BUT, we have all tried many ways that did not work. Like Sheriff Mack, we know taxes are not legal. We just continue to try the next gimmick that doesn't work.
 - The Department of Justice has a list of all the tax methods on their website called "[Illegal Tax Protestors](#)". For example:
- *40.02[1][b] Bogus Financial Instruments* (this comes straight from the book)
 - *For years, protesters have submitted bogus financial instruments to "pay" their tax liabilities and obtain erroneous IRS refunds, and to "pay" private creditors.*
 - This is the one I used many years ago and after years of battling the IRS, they finally cleared out my bank account one night. That issue has been cleared and I sleep well at night . . .

SheriffQ (cont.)

The need for a Constitutional Sheriff is imperative.

- However, three years ago I was introduced to the idea I want to discuss tonight. The DOJ list is updated yearly and offered to Prosecutors to assist them in putting we "Tax Dodgers" in jail. The tax process I mentioned is NOT in the list!
- Last year I followed the groups process and filed my 1040 as outlined and "payed zero" taxes with no consequences. The group's website is filled with testimonies of those who have received refund checks. The neat part is if one doesn't follow the instructions and the IRS doesn't accept the form, just refile and pay your taxes. Of course, having a "new Sheriff in town" is important too.
- This is one of the ways to begin an immediate funding of the Republik. I will address this in detail in the next presentation.
- I can go on for some time about the necessity of such a Sheriff. Just know that Sheriff Mack has agreed to train our Sheriff's when the need arises.

In Conclusion

- I am presenting a "transitional means" of funding the REPLIK. The "Banking Committee's" focus has been on seeking full funding of the Republik. Allow me to once and vehemently declare that I am in favor of a full funding of the Republik. For example, should the Dinar revalue or one of the many conspiracy theories come true such as the backing of our dollar by Gold I am in favor of it.
- BUT until then, a slow and transitional approach can only be wise. If voted in as "Chair of the Treasury", I will devote my time to making it happen.
 1. It begins with a bank (accounting system) that I think has all the functions that the Republik wants. No upfront investment. Free website. No need for web-building; it is already built and tested. There is no long term commitment so it is flexible for any change in the future. Please check out the demo site!
 2. Please read the article of the billionaire that bought nickels. Consider the simplicity of backing our currency (in the beginning) with nickels and pennies. I am being silly but one idea I had was to put all our nickels in a cage and leave it on the sidewalk overnight. Of course, surround it with deputies and rifles on the roofs and this would rid the community of thieves as they tried to steal the coins and the deputies got in some target practice.

In Conclusion (cont.)

 3. Use the website SheriffQ.com to assist in building your County.
- Consider the need for "a new sheriff in town" and contribute your ideas to the website. We need to think outside the box and fill needs in our community. I think growing food can be included somehow and helping one another build simple homes will remove the need for using the "Beast System" to create debt to buy a home with credit?

In Conclusion (cont.)

- Finally, I challenge you to find one of the methods you used for your taxes in the "Illegal Tax Protestors" publication that the Department of Justice created. I was taught as a Paralegal that one seeks the truth from all sides. Whether, I am trying to avoid taxes by:
 - Trusts
 - Church Schemes
 - Jury Nullification
 - Constitutional Challenges
 - Sixteenth Amendment Never Ratified
 - District Court Lacks Jurisdiction of Title 26 Offenses
 - Filing Income Tax Returns Is Voluntary OR
 - Wages Are Not Income
- It is important why the IRS is adamant they can bring actions against us and we should know their side of the argument. . .

In Conclusion (cont.)

I have found and tested this process and it is not listed by the Department of Justice and has been used for several years by taxpayers. They all have positive results and I am now one of them.

In the next class, I hope to present the founder of that process and HEY, as stated at the beginning of this presentation, let us keep an open mind and listen to what the guy has to say. Those of us who are still employed would love to find a way to deal with our tax situation honorably. And if we could put a bag of nickes away each week that would be better . . .
